Authorization/Permission to enter: By signing this Application and the Lease Agreement, customer (I) grants CSS permission to enter the Delivery Address identified above for the purpose of delivery, installation, repair, inspection and removal of the Equipment in accordance with the Lease Agreement terms and (ii) authorizes the building owner or it's representatives ("Owner") to permit CSS access to the Delivery Address and to release any Equipment to CSS, and customer agrees to hold Owner harmless from any actions in connection therewith.

Termination: Either party may terminate the Lease Agreement after the expiration of the initial minimum 4 month term upon 5 days prior notice. Upon termination customer will make the Equipment available to CSS at reasonable times for CSS and will permit CSS or it's agents to enter the Delivery Address for the purpose of taking possession of the Equipment. There is a penalty for early termination of the Lease Agreement.
